The latest VAERS data shows that there have been 3,725 fetal deaths after the C-19 vaccinations.

Most of the deaths have occurred due to the Pfizer vaccine.

The CDC shared that there have been 550million doses of C-19 vaccines administered only in the US.

It means that for every 147.651 doses of C-19 vaccines, there has been one fetal death.

There were more than 4 billion doses of the vaccines administered in the US from 2006 to 2019. Throughout this period, 1.369 fetal deaths have been reported in VAERS. Most deaths have been reported from the HPV vaccines.

It means that one death has been reported to VAERS from 2006 to 2019 for every 2.989,596 doses administered.

It's a 1.925 increase in fetal deaths after the rollout of the C-19 vaccine compared to all vaccines administered during the 14 years from 2006 to 2019.

CDC shared:

"COVID-19 vaccination is recommended for people who are trying to get pregnant now or might become pregnant in the future, as well as their partners. In addition, everyone who is pregnant, breastfeeding, trying to get pregnant now, or might become pregnant in the future, should get a booster shot. CDC recommends that people who are starting their vaccine series or getting a booster dose get either Pfizer-BioNTech or Moderna (mRNA COVID-19 vaccines), but the J&J/Janssen COVID-19 vaccine may be considered in some situations.

There is no recommendation for routine pregnancy testing before receiving a COVID-19 vaccine. If you are trying to become pregnant or may want to become pregnant, you do not need to avoid receiving a COVID-19 vaccine. Those who are trying to become pregnant do not need to avoid pregnancy after the COVID-19 vaccination. If you get pregnant after receiving your first shot of a COVID-19 vaccine that requires two doses (i.e., Pfizer-BioNTech COVID-19 vaccine or Moderna COVID-19 vaccine), you should get your second shot to get as much protection as possible.
