



BREAKING NEWS: Masks Off Toddlers In NYC! Judge Ordered Mandate Is Arbitrary, Capricious, And Unreasonable!!

Description

USA: This Friday, the New York State Supreme Court Judge issued an injunction on New York City's toddler mask mandate.

Mayor Eric Adams said that toddlers should remove their masks on April 4 if C-19 cases are still low.

But, the mayor's abusive and illogical mandate was axed in court.

Hon. Ralph J. Porzio of the NYSC 13th Judicial District wrote the toddler mask mandate and was found "by this court to be arbitrary, capricious, and unreasonable."

submitted in opposition thereto, after hearing oral arguments and for the reasons set forth on the
record, it is hereby

ORDERED that the declaratory judgment is granted and the portion of the Commissioner's
Order dated November 17 2021, colloquially known as the "toddler mask mandate" is found by
this Court to be arbitrary, capricious, and unreasonable.

ORDERED that in light of the declaratory judgment, a permanent injunction is hereby granted
and "toddler mask mandate" is void and unenforceable.
