“In my opinion, withholding scientific data constitutes fraud. This is scientific fraud,” Malone said during the interview, as well as in a joint statement he issued with Dr. Peter McCullough.

“In my opinion, if I was to publish a study in which I had a large body of epidemiologic data, and I decided to only public publish part of it because I wanted to advance some agenda, I would be guilty of scientific fraud. The paper would be withdrawn. I would be kicked out of my academic institution. I would be guilty of scientific fraud. That’s what this is.”

Malone went on to reveal that there will, without a doubt, be legal consequences for the CDC and anyone else who participated in the *plandemic* sham. He said these entities and people now have a choice about which side of history they want to be on when the house of cards finally collapses.

“I believe they have a choice,” Malone said. “These government employees have been participating in hiding this data. They can either be defendants or they can be witnesses.”
