

mRNA is an Operating System - Technology Platform per Moderna Website

#### **Description**



The 2021 Moderna site clearly defines mRNA as a software program that makes 'proteins' (artificially-

Pfizer describes their mRNA as a gene-editing technology on their website as well, not as a biological agent (vaccine).






