



NWO Zionist Lobby to Persecute Christians: Netanyahu in Jerusalem like Zelensky in Kiev

Christians will face jail in Israel for proselytising under proposed bill

“Men of Israel, consider carefully what you intend to do to these men. (...) Leave these men alone! Let them go! For if their purpose or activity is of human origin, it will fail. But if it is from God, you will not be able to stop these men; you will only find yourselves fighting against God”. Acts of the Apostles (5,34-39) – **Holy Bible**

“Why do the nations conspire and the peoples plot in vain? The kings of the earth rise up and the rulers band together against the Lord and against his anointed, saying, Let us break their chains and throw off their shackles. The One enthroned in heaven laughs; the Lord scoffs at them”. Psalms of King David (Psalm 2,1-4) – **Holy Bible**

These two passages from the Bible, expunged from the New and Old Testaments, narrate the fate of the wicked who challenge the Most High and Almighty God of the Jews and Christians. Both in relation to the tribes that opposed the peaceful colonization of the Chosen People of the Jews, and to the latter when they did not recognize the Messiah Jesus Christ and put him on the cross so that he could be resurrected and bear witness to being the Son of God.

In the Acts of the Apostles he is the doctor of the law Gamaliel. member of the Sanhedrin, who insinuates a witty and legitimate doubt before the High Priest who had Peter and the other Apostles arrested because they healed the blind and crippled in the Temple of Jerusalem by imitating their Master and preaching like Him the “Good News (from the Greek *euangélion*)”. The persecution of the Pharisees and of the even more politicized Sadducees, who by denying the Resurrection of the Dead had all their teeth poisoned against the witnesses of the Risen One, ended with the defeat of the Israelites and their Diaspora...

Zionists and Freemasonry in the New World

Today, unfortunately, the self-styled new heirs of this lineage are well represented by that part of Ashkenazi who founded the Zionist POLITICAL Movement. It is good to point this out so that the conspiratorial matrix of Zionism is briefly clear, which has very little to do with the Semitic descent of the ancient Jews.

As we have seen in previous investigations into the Zionist Lobby and the presumed Ashkenazi origins of Adolf Hitler, it is an “elitist coterie” of this kind of Khazar origin that proliferated thanks to the Freemasonry of the New World Order which, not surprisingly, was delighted with the birth of the American lodge B'nai B'rith International, in which contemporary relativist progressivism is well rooted, for example on the gender culture of LGBTQ propaganda.

Indeed, among the Ashkenazi, ironically defined by historians as “the 13th tribe of Israel”, there are not only fanatical Zionists who dream of rebuilding Greater Israel without the blessing of Jahwè since he placed Jesus as the “stumbling block for Zion (Jerusalem)” but also illustrious devotees of orthodox Jewish culture who do not complain about the divine curse of the Diaspora: such as Marc Chagall, a fervent Russian Yiddish who later became silently devoted to Christianity in France: his second homeland.

As always, we make this premise to avoid that some ignorant of Zionism accuse us of Anti-Semitism or worse still of outrage against the victims of **the terrible Shoah perpetrated by the Nazis also thanks to the economic support of John D. Rockefeller**, a fervent Protestant (Baptist) just like the Reverend James Anderson who wrote the rules of the Grand Lodge of London, the first official Masonic congregation in history.

The Persecution Ukrainian Orthodox by Ashkenazy Zelensky

Today as then, through a religious schism of a political nature (as were those of the Anglicans of Henry VIII King of England, of the Presbyterians of John Calvin and of the Lutherans of Martin Luther to subtract power from the Roman Catholic Church and from the Papal States in Europe and for to claim autonomy in the Protestant fold) the evangelical roots founded on love of neighbor are being denied, so much so as to start a systematic, malevolent and premeditated persecution of Christians.

The **increasingly pressing harassment of the Ukrainian President Volodymyr Zelensky against the Ukrainian Orthodox Church (UOC)** which depends on the Moscow Patriarchate have artfully created clues of espionage against the monks of the Monastery of the Caves of Kiev to deprive them of this historical seat and marginalize them despite having repeatedly been resolute in condemning the military operation of the Russian Army in the country.

With the excuse of favoring the minority Orthodox Church of Ukraine (OCU), founded on 15 December 2018 and recognized by the Greek Patriarchate of Constantinople on the inspiration of President Pedro Poroshenko as opposed to the Russian Orthodox Church, the head of the Ukrainian government is pursuing a religious discrimination of **the historic Ukrainian Orthodox Church, absolutely majority, which in recent days has also been contested by OHCHR, the Office of the High Commissioner for Human Rights of the UN.**

The pro-Nazi regime in Kiev, in fact, wants to ban the church with a specific legislation that openly contrasts with the Resolution 36/55 of 25 November 1981 of the General Assembly of the United Nations «on the elimination of all forms of ‘intolerance and discrimination based on religion or belief’.

In the third millennium where it is forbidden to discriminate even against Muslim Jihadists, extremists and terrorists of ISIS, solely for religious reasons, the purge operation is really macroscopic but it has been well tolerated by the hypocritical democracies of the NATO countries, among which there is the United Kingdom where Charles III was proclaimed King with legislation that contrasts with the same UN declaration as it guarantees descent only to Protestant heirs.

It should be noted that authentic Orthodox Jews, descendants of the ancient Israelites who never left the Holy Land, are not sympathetic to Zionism at all, as demonstrated during the latest reprisal against Gaza in 2020.

The Fanatics of Weapons Lobby

Here then, both in Eastern Europe and in the Middle East, are two analogous laws of religious persecution in contrast with any prohibition of discrimination by the UN which target Christians in compliance with that NWO of Masonic origin which over a century wrote the Declaration Balfour (1917) for the cession of the British colonies to the Zionists and who in 2014 planned, against the legitimately elected pro-Russian government, the bloody coup in Kiev financed by Soros and NATO countries, which subsequently allowed the Ashkenazi Zelensky to organize the first Gay Pride in June 2019, one month after his election as President of Ukraine.

Therefore, it does not seem a coincidence that the aberrant practice of “womb for rent” is one of the most well-known and lucrative businesses in the nation and that child prostitution is the most serious problem in Kiev and in the entire country...

In both countries, totalitarian extremist components govern who have based their new Zionist creed on the Weapons Lobby and military actions:

- Israel vs. water-rich Syria in Golan Heights still illegally occupied by Israeli Defense Force despite UN eviction resolutions
- Ukraine against the pro-Russian separatist republics of Donbass, in the American sights of Joe Biden and his son Hunter because he is rich in gas and oil, from which the current conflict with Russia has arisen.

In both cases the moral drift is **typical of two Zionists who probably never even read the Torah in their lives:** the Pentateuch of the Old Testament which contains many rigorous even extreme laws (an eye for an eye...) for the quiet life human in obedience to God but also many inspirations to mercy (freeing of slaves after the sixth year, prohibition of usury loans, etc.).

It does not seem to us a coincidence that fanatics with clear dictatorial ambitions were brought to power in two such strategic countries within the geopolitical chessboard of the Mediterranean Sea and Eastern Europe.

And unfortunately all this recalls the business undertaken by Rockefeller's Standard Oil which guaranteed Hitler's Third Reich the financial power indispensable to implement its plans for world destabilization and war.

Their persecution against Christians is instead similar to that which the emperor Nero carried out in Rome to amuse his senators and pagan citizens with "bread and circuses". In the blood of the martyrs for Jesus Christ the city Caput Mundi was shipwrecked. Just as a few years earlier Jerusalem had collapsed according to the predictions made by the wise Gamaliel before the Sanhedrin and mentioned in the Acts of the Apostles.

A similar fate befell the Savoy dynasty in more recent centuries when King Vittorio Emanuele II signed the Masonic law for the closure of ecclesiastical orders and the expropriation of their assets.

Christians could face one year prison sentence for encouraging conversion to their faith, according to a new controversial legislation being introduced in Israel. The legislation which is being proposed by ultra-Orthodox members of Benjamin Netanyahu's coalition would also proscribe Christians from engaging in religious discussion with Jews.

Titled Proposed Penal Law: Amendment – Prohibition of Solicitation for Religious Conversion – 2023, the legislation is introduced by United Torah Judaism's Moshe Gafni and Yaakov Asher. The law would apply to anyone who would attempt to persuade someone to change their religious beliefs, however the legislation specifically mentions the Christian faith, saying that **"recently, the attempts of missionary groups, mainly Christians, to solicit conversion of religion have increased."**

"Solicitation", according to the text of the legislation, refers to anyone "who solicits a person, directly, digitally, by mail, or online in order to convert his religion" and the punishment for such solicitation is "one year imprisonment; and if the person was a minor, the punishment – two years imprisonment."

According to All Israel News, the bill "appears to be making it illegal for followers of Jesus ("Yeshua" in Hebrew) to explain why they believe that Jesus is both Messiah and God with the hope that Israelis might consider following Him." The Jerusalem based news agency explained that under the new legislation "producing and publishing online videos explaining the Gospel to Jewish or Muslim people in

Israel – and to those of any other religious faiths – would suddenly become illegal.”

Publishing books, other printed literature, online articles, podcasts, or other forms of media that explain the life and ministry of Jesus and His message found in the New Testament would also become illegal.

The proposal has created friction with America’s evangelical community who are strong supporters of Israel. Leading evangelical Christians are publicly urging Prime Minister Benjamin Netanyahu to scuttle legislation, according to Haaretz. Apparently, Netanyahu and his allies have publicly and privately stressed the importance of evangelical support as US Jews have grown increasingly critical of Israel’s rightward shift.

It is expected that the bill will be sharply criticised in Washington by both Democrats and Republicans alike.

Ukraine criticizes UN human rights body on crackdown on the Ukrainian Orthodox Church

The UN’s human rights watchdog should “refrain from unbalanced political assessments,” a spokesman for the Ukrainian Foreign Ministry has demanded, following a report that questions Kiev’s treatment of the largest religious denomination in the country.

“Ukraine is a democratic nation, where freedom of religion is guaranteed. But freedom does not equate to a right for activities that undermine national security,” Oleg Nikolenko told Ukrainian media on Monday. He urged the UN to “base its reports on facts.”

Last Friday, the UN’s Office of the High Commissioner for Human Rights (OHCHR) released a report expressing concern about the crackdown on the Ukrainian Orthodox Church (UOC), which has historic links with the Russian Orthodox Church.

The SBU, Ukraine’s domestic security agency, has targeted UOC clergy and property in a series of raids over the past several months. The secret service claimed that churches could be hiding weapons and saboteurs and that the UOC served as an arm of the Russian government. **The UN body said it was “concerned that the State’s activities targeting the UOC could be discriminatory.”**

The OHCHR also mentioned several bills introduced in the Ukrainian parliament which were apparently aimed at undermining the UOC. Sponsors of the proposed legislation used “vague legal terminology” and failed to provide “sufficient justification,” according to the report.

The UN warning came days before monks belonging to the UOC are supposed to leave their homes at the Kiev Pechersk Lavra, an iconic monastery in the Ukrainian capital.

The Culture Ministry has refused to renew their lease of the property, which is owned by the state. Minister Aleksandr Tkachenko indicated that the monks could stay, provided that they abandon the UOC and join the Kiev-approved Orthodox Church of Ukraine. President Vladimir Zelensky, meanwhile, has made clear that he supports the ouster, which he claimed would strengthen the “spiritual independence” of the country.
