



People are getting cancer from covid jabs, but the truth is being hidden

Description

USA: An insider who claims to be a former intelligence official is warning that Wuhan coronavirus (Covid-19) “vaccines” cause cancer, and the government is covering up the truth.

Cancer rates are skyrocketing in the age of Operation Warp Speed, according to seven out of the 11 International Classification of Diseases (ICD) codes tracked by the U.S. National Center for Health Statistics, and it all began around the first week of April 2021.

Other diseases are soaring, too, but for the purpose of this article we will focus primarily on the *Big C*. There is a clear and undeniable correlation between higher rates of cancer and the introduction of Fauci Flu shots in early 2021.

CDC redefines cancer deaths as “covid” deaths

Dr. Jennifer Brown, who publishes articles to Substack, shared a graph showing the normal cyclical wave pattern of cancer over the years. From January 2015 to early 2021, the wave looks generally normal – then everything changes.

Suddenly, the pattern broke upward like a stock after a good news rumor and has never really stopped increasing since.

“We should be at or near a seasonal nadir,” Brown writes. “Instead, we are at an all-time CA [cancer] excess, and heading up. Keep in mind there is substantial lag to CA reporting, so this likely under-

represents true excess.”

At no point in at least the past seven years has anything like this occurred with regard to cancer. As we said, cancer rates usually only go up and down seasonally, staying within a general range – but no longer.

Most Americans have no idea about any of this because the U.S. Centers for Disease Control and Prevention (CDC) is hiding cancer death statistics by re-categorizing them as “covid” deaths.

Just like everything else over the past nearly three years, every death no matter the cause is now being labeled a “covid” death. This is one of the ways that government officials and their puppet masters are able to conceal the truth.

“The set dynamics are complex, but the principle is straightforward,” reports explain. “When a death cert lists Cancer as the UCoD [underlying cause of death] and COVID as MCoD [main cause of death] – the UCoD & MCoD are being swapped, and COVID is being listed as the UCoD 100% (425/wk).”

“This results in 20% of all COVID deaths each week, also happening to be persons dying of Cancer – which is egregiously higher than it should be. This is clear over-attribution = equates to exactly the difference between the Cancer and All Other ICD-10 code lag curves.”

Problems arise, however, once “covid mortality” is no longer a substantial enough figure to conceal excess mortality – then what?

In essence, the CDC is swapping the underlying and main causes of death in its official datasets which, to some degree, hides the fact that cancer deaths are currently through the roof.

“According to his analysis, the COVID shot is killing 7,300 Americans per week. COVID, meanwhile, is killing 1,740 people,” *Newspunch's* Sean Adl-Tabatabai.

“So, what will the CDC blame when COVID disappears and they can no longer swap the underlying and main cause of death designations?”
