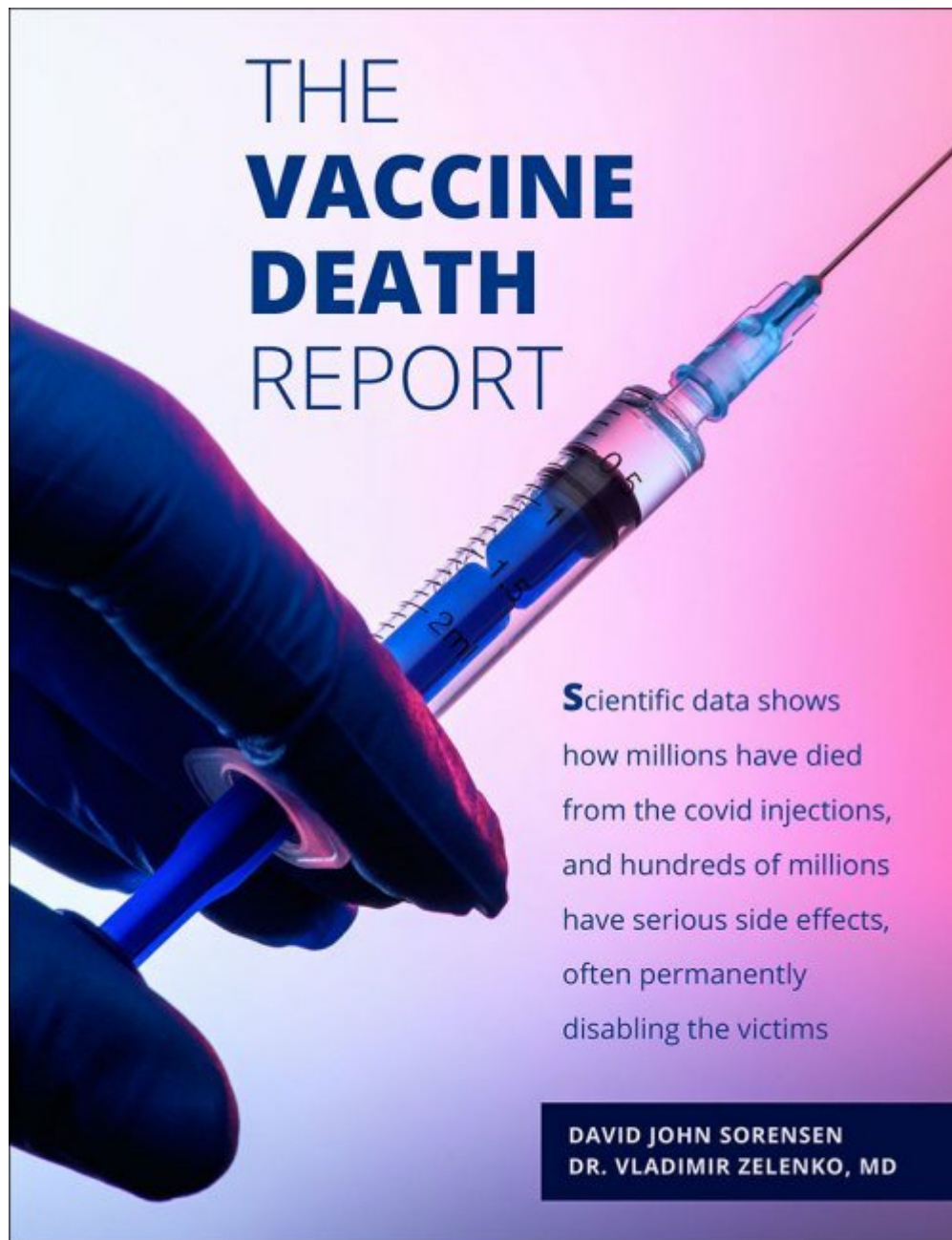




Previously Unavailable FDA, Pfizer Data Shows Shocking Death/Injury Totals

its efficacy and safety.



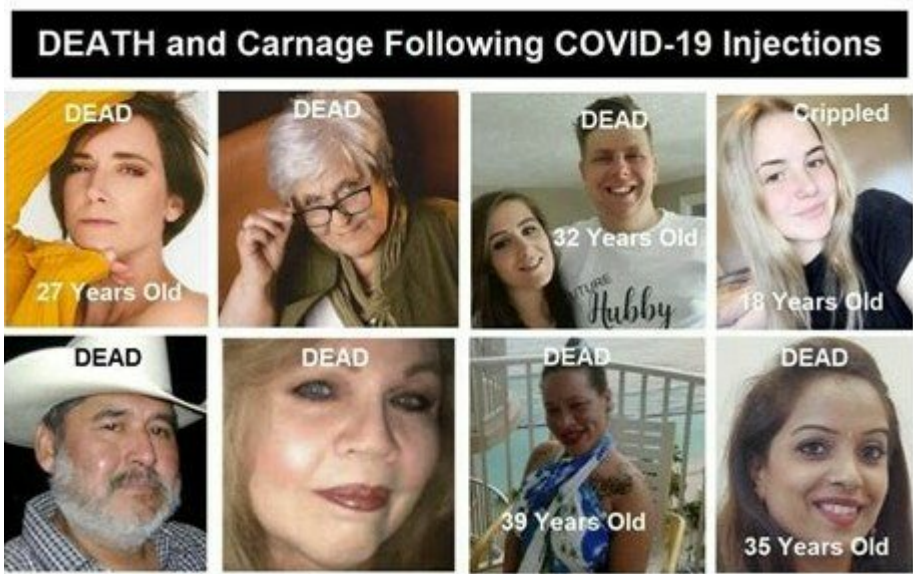

?Since the vaccine mandates and jabs began, there has been an 84 percent increase in mortality of Millenials (ages 22-44) according to CDC data.

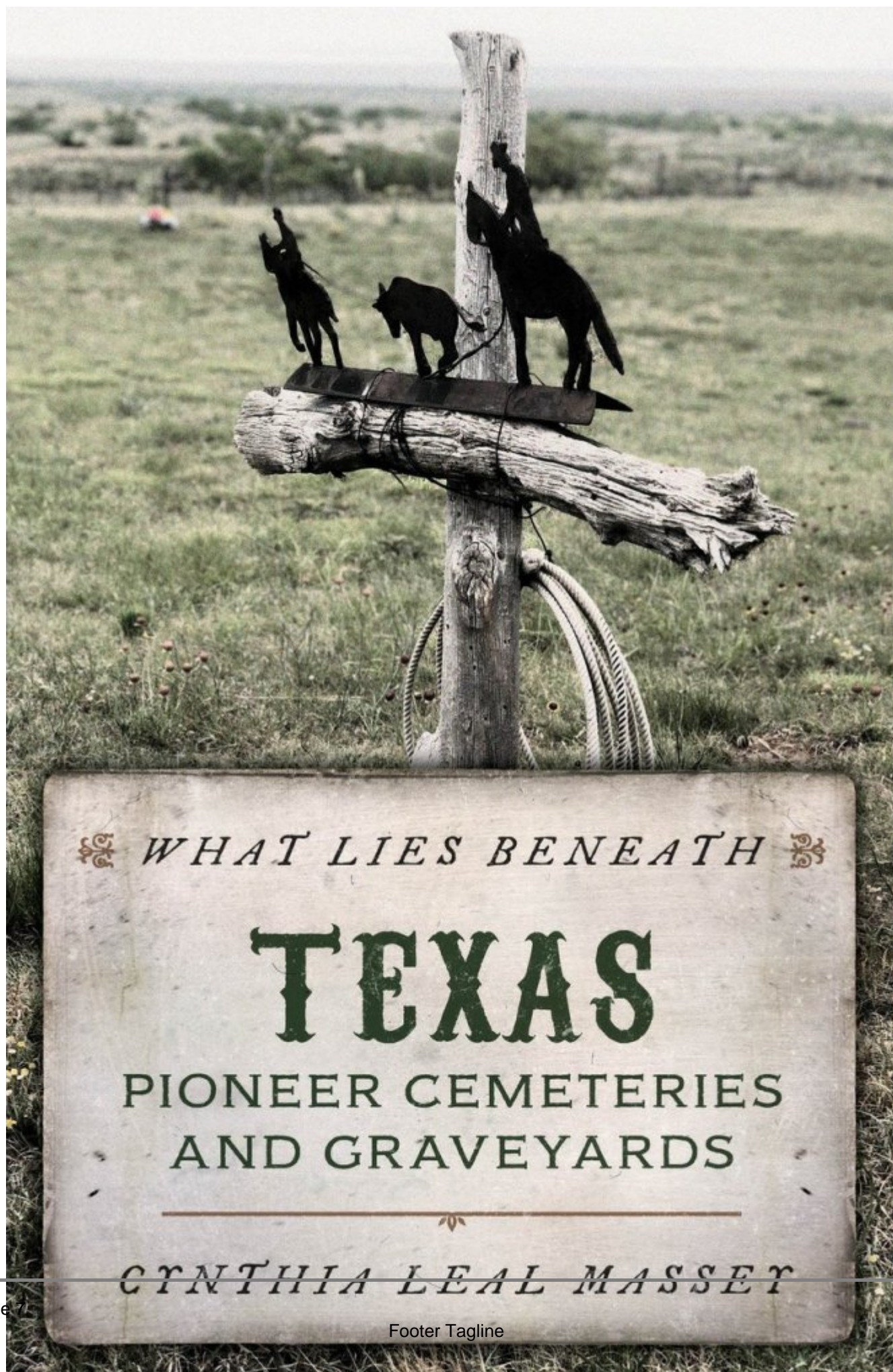
?There has been a startling increase in healthy vaccinated child-bearing age women who were are being hospitalized with blood clots in the brain.
