Here is Biden admitting his crimes as Vice President.

Here is the section from the Burisma email.

The complete email thread is posted below.

Apart from that, they would unofficially approach our partners, our suppliers trying to intimidate them to stop working with our company.

These are typical instruments to destabilize business.

We urgently need your advice on how you could use your influence to send a message / signal, etc. to stop what we consider to be politically motivated actions bearing in mind the following:

Burisma holdings is a leader among private gas producers;  
Our primary client is Accelor Mital- Ukraine's biggest metal steel producer  
cover more than 60% of its gas needs.

Our clients and their production are largely dependant on our work and our ability to perform our contractual obligations;

We employ hundreds of employees etc. and etc.;

A short time later in early 2016 Joe Biden had Viktor Shokin, the prosecutor investigating Burisma fired.
