

STOLTENBERG: NATO's Puppet for Gates, NWO in Pandemic as in Ukrainian War

Description

These are the conclusions of a study of health geopolitics published in the scientific journal PMC (US National Library of Medicine National Institutes of Health) on March 25, 2021, by various researchers including the first signatory John M. Quinn, who declared himself in conflict of interest in as a cofounder of the Prague Center for Global Health and a former temporary medical officer at the OSCE in Ukraine from August 2020 to April 2021.

«There is no indication that NATO will call COVID-19 a challenge to the alliance, necessitating joint and effective action on the part of all the allies to craft a collective response, although this is possible. But most importantly, the instability and vulnerability of NATO and NATO members is at its highest point since the initiation of the alliance. Land, sea, air, space, and cyber domains are vulnerable to

Ukraine is in a unique position of not only being the only EU state in open and active combat with Russia and Russian backed proxies but also dealing with the COVID-19 threat at the same time» added John M. Quinn along with others.

This research, which correlates the pandemic with a military conflict, takes on significant significance after the escalation of the Donbass conflict: from where an 8-year civil war with 10,000 dead exploded in a national conflict event for the invasion of Russia aimed at protecting the pro-Russian of the separatist republics of Donetsk and Lugansk.

But as we know, NATO has not lifted a finger to intervene militarily: as if it were a trap to discredit Moscow worldwide using the population of Ukraine as bait.

THE GATES' AFFAIRS IN THE PANDEMIC

All of this could appear as a rash move by a politician who has held the reins of world security since 2014 and has been extended at the NATO summit until September 2022, thanks to the pandemic.

But if we carefully analyze his past and future Stoltenberg's curriculum we see very clearly his role as a puppet of the New World Order and in particular of Bill Gates: the most tangible face of this occult and secular entity of financiers, mostly Zionist Masons and apparatuses of military intelligence.

Not only. Microsoft Corporation has already entered into international agreements for the management of innovative Artificial Intelligence projects both with the Pentagon, Washington Department of Defense, and with Leonardo, the Italian war industry controlled by the state but participated by notorious hedge funds such as the New Yorker BlackRock.

According to lawyer Robert F. Kennedy jr, Gates is also one of the architects of a pandemic planned for decades: he has in fact financed the University of Wuhan, which collaborates with the Wuhan Institute of Virology (WIV), with 500 thousand dollars.

But BMGF also donated 1.5 million to New York's Eco Health Alliance (EHA) which funded the dangerous chimeric virus experiments in which zoologist Peter Daszak, EHA president, collaborated side by side with Shi Zhengli, the director of the WIV Infectious Diseases Research Center.

The so-called <u>Chinese "bat-woman" worked in turn in SARS tests with Gain of Function</u> – viral load enhancement for Dual-Use vaccine or bacteriological weapon – with <u>Ralph Baric of the University of North Carolina</u> thanks to funding from the NIAID (Institute National Allergy and Infectious Diseases) directed by Anthony Fauci, White House consultant on the Covid-19 emergency.

Gates, the main financier of the WHO, has also chosen Ethiopian biologist Tedros Adhanon Gebreyesus, who himself previously introduced into business with China, as director of the UN health agency, who had the task of declaring the pandemic from SARS-Cov. -2 (built in the laboratory

according to authoritative virologists and intelligence experts and as demonstrated by our WuhanGates investigations), fulfilling the first necessary requirement for an emergency authorization for the use of experimental gene sera, such as those RNA vectors produced by Moderna and Pfizer-Biotech thanks to funding from the Pentagon and Gates himself.

Conflicts of interest are macroscopic and ignored by the mainstream media themselves funded by Gates. But they don't end there. The same BMGF in 2018 funded a mysterious study on particularly lethal pathogens at the Pirbright Institute in the UK together with DARPA, the Pentagon's special projects agency that had just refused to work on a SARS project in the US of President Donald Trump that in the fall of 2019 it stopped government funding to the Eco Health Alliance.

Gates, together with the World Economic Forum, also financed the simulated exercise on a coronavirus pandemic Event-201 held in New York two months before the outbreak of the real Covid-19 emergency which was also attended by a former CIA deputy director expert in bacteriological weapons and later promoted by President Joseph Biden national director of the US Intelligence Community.

THE ROLE OF STOLTENBERG IN GAVI VACCINES

Having presented all the shady conflicts of interest initiated by the IT guru both in the military and above all in the health field, let's see what was the important role of Jens Stoltenberg in the field of vaccines.

The Parliament of Norway also announced today new funding to support GAVI, pledging a total of \$290 million from 2005 through 2010 – nearly \$50 million (300 million kroner) each year. This contribution brings Norway's total commitment to GAVI to date to \$400 million reads an article from the Bill & Melinda Gates Foundation.

"Immunizing children is one of the most important and cost-effective development investments donor governments can make," said Jens Stoltenberg, Vaccine Fund board member and former Prime Minister of Norway, who negotiated Norway's first grant to GAVI. "Children must have a healthy start if we hope to reduce poverty and build strong economies."

Other governments pledging new support for GAVI in the past year include the United States, Sweden, Denmark, and Luxemburg. Since 1999, GAVI and The Vaccine Fund have raised more than \$2.3 billion from public and private donors, including the contributions, announced today.

GAVI was launched in 2000 to address the fact that more than two million people in developing countries die needlessly each year because they do not receive the immunizations that are taken for granted in the industrialized world.

According to the GAVI Alliance statistic numbers, the main donors with total contributions and commitments for the 2000-2019 period are the United Kingdom 3,826 (in US\$ millions), France 1,738,

Italy 1,236, Norway 838, United States of America 647, Canada 403.

The number of donors is 17 countries and European Commission. The total amount of contributions and commitments for 2000-2019 years is 10,17 US\$ billion. An additional 1,66 US\$ billion for the same period is donated by private donors.

Norway, a country with a population of just 4.5 million, is having a disproportionately big effect on global health. It was the first country to fund the GAVI Alliance and is still the second-largest donor after the Gates Foundation. Norway has publicly committed in a way that larger nations are not to the Millennium Development Goal of cutting child deaths (MDG4)» instead wrote the scientific journal The Lancet, of which Dr. Daszak himself is an influential scientist who, with a very confidential (but later discovered) email, invited 27 of his colleagues to immediately oppose the theory of artificial SARS-Cov-2.

Much of this is credited to the leadership of Prime Minister Jens Stoltenberg, who has made the drive for improved global health central to Norway's foreign policy. It is a personal crusade but, Stoltenberg says, pointing out that Norway is the seventh-largest donor to the UN, it is one that comes naturally to Norwegians» added The Lancet.

SOLTENBERG: FROM GAVI ALLIANCE VACCINES TO NATO

Jens Stoltenberg (Oslo, March 16, 1959) is a Norwegian politician, leader of the Norwegian Labor Party (Arbeiderpartiet, AP), Secretary-General of NATO since October 1, 2014. On February 4, 2022 he was officially appointed incoming governor of Norges Bank starting from September.

He is the son of Labor politician Thorvald Stoltenberg (1931-2018), ambassador, defense minister, and foreign minister, and of Karin Stoltenberg (nee Heiberg) (1931-2012) geneticist who was Secretary of State in several governments during the 1980s.

From 17 October 2005 to October 2013 he held his second office as Prime Minister of the Kingdom of Norway. The first was very short, from March 2000 to October 2001. Between his first and second assignments, Stoltenberg headed the Gavi Alliance, the foundation funded by Bill Gates that works to promote the spread of vaccines globally.

This happened during the first SARS epidemic (from the English acronym of Severe Acute Respiratory Syndrome) of 2003 following which the European Commission chaired by the Italian Romano Prodi in 2004 financed the first research on the <u>chimeric SARS viruses infected with HIV in the Wuhan Institute.</u> of Virology.

After the outbreak of the COVID-19 pandemic, which is suspected to have been caused by a laboratory virus like the one in 2003, Gates' GAVI Alliance assumed a global strategic role together with CEPI.

Let's see shortly who are the protagonists and the objectives of Predict. First, we recall that GAVI and CEPI have been called by the WHO, of which the self-styled philanthropic body of Gates is the first financier, to manage the Covid-19 emergency. The plan, administered by the former manager of GlaxoSmithKline, the London-based Big Pharma of which a director of Microsoft is CEO, proved to be a half-failure due to the low

adhesion of nations.

But it helped US President Joseph Biden to repay <u>Pfizer</u>, sponsor of many <u>Democratic Party electoral</u> <u>committees for about \$ 2.2 million</u>, giving COVAX \$ 4 billion from the US administration for the purchase of half a million doses. of the Comirnaty vaccine, produced by <u>Pfizer</u> (partner of GSK) and by <u>Biontech</u>, financed by <u>Gates</u> in endless speculation that cries out for revenge.

MILITARY RESEARCH IN THE PREDICT PROJECT

PREDICT, a project of USAID's <u>Emerging Pandemic Threats</u> (EPT) program, was initiated in 2009 to strengthen global capacity for detection of viruses with pandemic potential that can move between animals and people. PREDICT has made significant contributions to strengthening global surveillance and laboratory diagnostic capabilities for both known and newly discovered viruses within several important virus groups, such as filoviruses (including ebolaviruses), influenza viruses, paramyxoviruses, and coronaviruses.

But among the partners, there are also the WHO and the Wuhan Institute of Virology which has had a fundamental part in research and dangerous experiments on viruses.

As part of this global project, PREEMPT research has been launched which aims to predict the emergence of highly pathogenic viruses in animals and thus prevent them from completely spilling onto humans using strategies that include a new animal vaccine.

Led by the One Health Institute in the UC Davis School of Veterinary Medicine and the <u>Center for Comparative Medicine</u> in the UC Davis schools of Medicine and Veterinary Medicine, this research is funded by the Defense Advanced Research Projects Agency (DARPA) as part of its Preventing Emerging Pathogenic Threats (PREEMPT) program.

Therefore it is a Pentagon initiative that can be seen in a Dual Use objective with defense purposes in the search for a vaccine or attack for the development of a bacteriological weapon. Let's not forget that the first biological warfare exercise of the US Navy dates back to 1952 as confirmed by a <u>declassified</u> video published exclusively by Gospa News.

NORGES BANK'S BUSINESS ON VACCINES AND WEAPONS

Soltenberg's commitment to the massive promotion of vaccines in children is similar to that already implemented in Italy with the pilot project of the Global Health Security Agenda imposed by President Barack Obama in agreement with premier Matteo Renzi and Paolo Gentiloni, in an agreement between Democratic Party and Italian PD.

The enormous criticality of these global immunization ambitions has been brought to light by the <u>numerous adverse reactions, including lethal ones</u>, resulting from the administration of experimental gene sera in the population, especially in Italy, the United Kingdom, and the USA: where some categories have been subjected to a binding obligation to maintain the workplace.

Cui prodest? Who benefits from all this? Surely at Big Pharma under a double aspect: The "free" experimentation on human guinea pigs that could end up with altered DNA or be part of even more disturbing projects of neurocerebral control through graphene (an initiative of DARPA and Obama).

But above all, the enormous turnover of pharmaceutical companies for the sale of anti-Covid vaccines that the European Commission chaired by Ursula von der Leyen has already purchased in 4.2 billion doses: equal to 10 doses for each EU citizen.

Well, among the beneficiaries of this business there is also the Bank of Norway, a national central bank since 1816, of which Jens Stoltenberg will become president from September 2022 when he leaves his post as NATO secretary (except for further extensions due to the war in Ukraine).

Norges Bank Investment Management holds 2.44% of the shares of GlaxoSmithKline, on which Gates speculates as confirmed by the role of CEO of Emma Walmsley, director of Microsoft.

GSK has been the majority partner in the <u>Consumer Healthcare Joint Venture with Pfizer</u>, manufacturer of the Comirnaty vaccine, since August 2019. However, <u>the Norwegian national bank</u> <u>also holds 1.08 percent in the same American multinational Pfizer</u>. While it controls <u>2.36% of Astrazeneca</u>, producer of the adenoviral gene serum Vaxzevria.

Bank of Norway which, incidentally, is anything but a second-rate financial institution. In fact, through the Norwegian sovereign fund (Government Pension Fund Global), it makes investments all over the world. In the first six months of 2021, it earned about 100 billion euros thanks to the performance of the stock markets after the crisis caused by Covid-19, as the bank itself announced» reads the Italian geopolitical blog Clarissa.it.

The value of the fund as of June 30th increased to 11.673 billion crowns, equal to 1.117 billion euros. In the first half of the year, it had a return of 9.4%, or a gain of 990 billion crowns (94.7 billion euros), thanks mainly to its equity investments, which represent 72.4% of its portfolio and had an overall growth of 13.7%.

«Equity investments made the highest contribution to returns in the first half of the year, especially

investments in the energy and finance sectors. Investments in energy companies yielded 19.5%» Nicolai Tangen, CEO of Norges Bank Investment Management, the branch of the Norwegian central bank that manages the fund, said in a statement. The health and technology sectors had solid returns during the pandemic and the increase continued in the first half of the year. Tech companies returned 16.8%.

The Bank of Norway, like the Fed, invests directly in equities and bonds. Not surprisingly, we often find the Norwegian bank alongside BlackRock and Vanguard, the main investment funds globally in many equity investments in strategic companies around the world reported Clarissa.it.

Among these, in addition to the Big Pharma that profited from the pandemic triggered by a bacteriological weapon, <u>according to the late Luc Montagnier</u> and the <u>bio-engineer Pierre Bricage</u>, <u>NATO lecturer</u>, there are also the international war industries.

Referring, for ease of research, to the dossier published by Gospa News in 2019 on the Weapons Lobby we see that Norges Bank Investment Management is a major shareholder of 6 corporations: at the time it had 0.89% of the French company Thales (created by Dassault Aviation sa), 1.74% of the Italian Leonardo (third shareholder after the Government and The Vanguard), 2.76% of the German Rheinmetall (involved in the scandal for the bombs built in the Italian branch in Sardinia and found in Yemen where there is the arms embargo) of which he was the second-largest shareholder after Capital Research & Management Co, 0.26% of the Turkish Aselsan Elektronik Sanayi Ve Ticaret As, 1.61% of the Japanese NEC Corp, and 3.94% of Qinetic Group plc.

This is why Stoltenberg appears as the ideal puppet of Gates and the New World Order in that Great Reset project theorized by Klaus Schwab, president of the World Economic Forum, where the Microsoft tycoon posed with the then Norwegian prime minister before he was chosen by NATO. as secretary to handle a suspected bioweapon pandemic and the war crisis in Ukraine.
