

UN Urges Govt's To Legalize Sex Between Adults and Minors: 'Pedophiles Deserve Love Too'

Description

The United Nations issued a report last month ordering government's to begin legalizing sex between adults and minors as part a drive to normalize pedophilia.

The disturbing <u>report</u> is titled "The 8 March Principles for a Human Rights-Based Approach to Criminal Law Proscribing Conduct Associated with Sex Reproduction, Drug Use, HIV, Homelessness and Poverty."

Hidden on page 22 of the report, the UN declares, "With respect to the enforcement of criminal law, any prescribed minimum age of consent to sex must be applied in a non-discriminatory manner . Enforcement may not be linked to the sex/gender of participants or age of consent to marriage."

The report adds, "Moreover, sexual conduct involving persons below the domestically prescribed **minimum age of consent to sex may be consensual in fact,** if not in law.".

PRINCIPLE 16 - CONSENSUAL SEXUAL CONDUCT

Consensual sexual conduct, irrespective of the type of sexual activity, the sex/ gender, sexual orientation, gender identity or gender expression of the people involved or their marital status, may not be criminalized in any circumstances. Consensual same-sex, as well as consensual different-sex sexual relations, or consensual sexual relations with or between trans, non-binary and other genderdiverse people, or outside marriage – whether pre-marital or extramarital – may, therefore, never be criminalized.

With respect to the enforcement of criminal law, any prescribed minimum age of consent to sex must be applied in a non-discriminatory manner. Enforcement may not be linked to the sex/gender of participants or age of consent to marriage.

Moreover, sexual conduct involving persons below the domestically prescribed minimum age of consent to sex may be consensual in fact, if not in law. In this context, the enforcement of criminal law should reflect the rights and capacity of

Per Live Action:

A new report from the United Nations has called for all forms of drug use and sexual activity to be decriminalized globally.

Written by the International Committee of Jurists (ICJ), UNAIDS and the Office of the High Commissioner for Human Rights (OHCHR), the report was released on International Women's Day, with the goal of guiding "the application of international human rights law to criminal law." Called the "8 March principles," the report calls for offenses related to "sex, drug use, HIV, sexual and reproductive health, homelessness and poverty" to be decriminalized.

The United Nations experts say that criminalizing offenses related to these issues constitute an attack on human rights.

"Criminal law is among the harshest of tools at the disposal of the State to exert control over individuals... as such, it ought to be a measure of last resort however, globally, there has been a growing trend towards overcriminalization," Ian Seiderman, Law and Policy Director at ICJ, said in the press release. "We must acknowledge that these laws not only violate human rights, but the fundamental principles of criminal law themselves."

Thegatewaypundit.com reports: The report also calls for all sex work to be decriminalized.

PRINCIPLE 17 - SEX WORK

The exchange of sexual services between consenting adults for money services and communication with another about, advertising an offer for, premises with another for the purpose of exchanging sexual services consenting adults for money, goods or services, whether in a public or priv may not be criminalized, absent coercion, force, abuse of authority or fra-

Criminal law may not proscribe the conduct of third parties who, directly or for receipt of a financial or material benefit, under fair conditions – without force, abuse of authority or fraud – facilitate, manage, organize, commun another, advertise, provide information about, provide or rent premise purpose of the exchange of sexual services between consenting adults to goods or services.

The United Nations new report is troubling considering they have been plagued with sexual abuse scandals.
