Phase 3 trials, which are often the largest and most time-consuming phase, involved thousands to tens of thousands of participants.


These trials aimed to determine the vaccine's efficacy in preventing the target disease while closely monitoring for any potential side effects.

The decision to do this was extremely questionable when we consider that Bill Gates has shares in the major Covid-19 vaccine companies and was also a major funder of medicine regulators through his foundation.

The Bill and Melinda Gates Foundation has been a significant contributor to global health initiatives, including vaccine research and development. The foundation has provided funding for various organizations involved in vaccine development and delivery, including the World Health Organization (WHO), the Coalition for Epidemic Preparedness Innovations (CEPI), and Gavi, the Vaccine Alliance.

Therefore, this conflict of interest stinks of corruption as Bill Gates could have threatened to withdraw his funding to medicine regulators if they failed to grant EUA of the Covid-19 injections he had shares in to increase his return on those shares.

In 2017, the UK Medicine Regulator, the MHRA, received a grant from the Bill & Melinda Gates Foundation worth £980,000 to facilitate a "collaboration" between the two entities.

While this relationship might not have raised eyebrows under different circumstances, the fact that the Gates Foundation owns shares in companies developing Covid-19 vaccines authorized for emergency use in children by the MHRA raises questions about potential conflicts of interest.

In 2016, Moderna announced that the Bill & Melinda Gates Foundation had granted them

\$20 million to support their initial project, which involved the evaluation of antibody combinations in a preclinical setting and the conduct of a Phase 1 clinical trial for a potential mRNA injection.

In January 2016, we entered a global health project framework agreement with the Bill & Melinda Gates Foundation to advance mRNA-based development projects for various infectious diseases. The Bill & Melinda Gates Foundation has committed up to \$20.0 million in grant funding to support our initial project related to the evaluation of antibody combinations in a preclinical setting as well as the conduct of a first-in-human Phase 1 clinical trial of a potential mRNA medicine to help prevent human immunodeficiency virus, or HIV, infections. Follow-on projects which could bring total potential funding under the framework agreement up to \$100.0 million (including the HIV antibody project) to support the development of additional mRNA-based projects for various infectious diseases can be proposed and approved until the sixth anniversary of the framework agreement, subject to the terms of the framework agreement, including our obligation to grant to the Bill & Melinda Gates Foundation certain non-exclusive licenses.

Moderna also revealed that the framework agreement between Moderna and the Gates Foundation could potentially result in total funding of up to \$100 million for follow-on projects proposed and approved by the Gates Foundation through 2022.

As part of this agreement, Moderna is obliged to grant the Gates Foundation certain non-exclusive licenses.

The Bill & Melinda Gates Foundation also <u>bought shares in Pfizer</u> back in 2002 before "coincidentally" buying <u>\$55 million worth of shares in BioNTech</u> in September 2019, just before the alleged Covid-19 pandemic struck.

The partnership between Pfizer and BioNTech has proven to be highly profitable, as their Covid-19 vaccine was among the first to receive emergency use authorizations worldwide.

This rapid approval and widespread distribution have resulted in a substantial increase in the stock prices of both companies.

Consequently, the Gates Foundation's investments in these corporations have also grown in value, adding to the foundation's already significant wealth.

### Pfizer

Bill Gates recently stated that he views **Pfizer** (**PFE -0.11%**) as the leader in the coronavirus vaccine race. In a CNBC interview, he said, "The only vaccine that, if everything went perfectly, might seek the emergency use license by the end of October, would be Pfizer."

The Gates Foundation also owns shares of the big drugmaker. However, this investment wasn't initiated because of Pfizer's coronavirus program. Actually, the foundation first bought a stake in Pfizer back in 2002 with the stated intention of "expand[ing] access to the pharmaceutical company's all-in-one injectable contraceptive, Sayana Press, giving women in the developing world an affordable option."

Gates is probably correct in assessing Pfizer as the coronavirus vaccine leader. The company expects to report initial results next month from a late-stage study of BNT162b2, the COVID-19 vaccine candidate that it's developing with **BioNTech (BNTX -2.31%)**. If all goes well, BNT162b2 could very well become the first coronavirus vaccine available to Americans.



### BioNTech

It's not surprising that the Bill & Melinda Gates Foundation also owns shares of BioNTech. Again, though, the nonprofit foundation didn't invest in the German biotech stock because of its coronavirus program.

The Gates Foundation first bought a position in BioNTech in September 2019, well before the COVID-19 pandemic hit. It invested \$55 million in the biotech, with the potential for total funding to reach \$100 million. The foundation's goal with this investment was to work with BioNTech to develop vaccines and immunotherapies for preventing HIV and tuberculosis (TB) infection.


BioNTech began developing its BNT162 COVID-19 vaccine program earlier this year. It had already made significant progress with this program when it announced a partnership with Pfizer in March.






 Newborn Baby Deaths hit critical levels for 2nd time in 7 Months in March 2022. (Source)




